
Quick Reference for Delta Sigma Pi Standards Process - Not in effect until 7/1/2023

Overview

The effort of the National Standards Committee, and previously the Individual Discipline Policy (IDP) Taskforce, focused on better aligning the chapter trial process with discipline processes of our host institutions to minimize the process confusion for our collegiate members. As a means to achieve this goal, the revised process will center primarily on restorative justice practices instead of a "court of law" feel.

The revised IDP, proposed by the task force, includes: updated terminology, the removal of Executive Committee and Chapter Trials and their replacement with a Standards Committee and Hearing Panel structure, an updated process flow to expedite the process and reduce biases, and updated alumni volunteer roles that provide structures beyond the collegiate chapter.

Overview of Revised Individual Discipline Policy

Committee consists of Chancellor and at least three additional committee members

Below is the role(s) for the Standards Committee(s) and how they execute the Standards Committee process:

Chancellor

- Ensuring all members of Chapter Standards Committee are properly trained
- Appoints Standards Committee members to a Hearing Panel
- Presiding over all hearings conducted
- Reports results

Committee Members

- Supports chapter compliance with all national and local Fraternity Ritual, Bylaws, and Policies/Procedures
- Serve as members of a Hearing Panel
- Determine results and behavior correcting measures

District Directors/Chapter Advisors

- Advise chapter through navigation of standards process
- Supporting the chapter in their decisions
- Providing guidance on tough conversations

Provincial Standards Committee

- Reviews allegations of alumni members
- Navigating Allegations reviewed by this committee include any that involve sexual harassment/misconduct/assault

National Standards Committee

- Develop all training elements for Provincial and Chapter Standards Committees with the support of Central Office staff
- Ensure each Standards Committee is adequately trained in the individual discipline process.
- Serve as an appellate to any standards committee, Chapter or Provincial, decisions.
- Serve as an ongoing resource for all standards committees

Standards Process

- 1. Allegation Submitted
- 2. Review of Allegation by Standards Committee (up to 14 days)
- 3. Informal Meeting between the Chancellor and respondent (individual with submitted allegation(s))
- 4. Hearing with Chapter Standards Committee*
- 5. Outcomes are reported in Hub and at chapter meeting

* If a member accepts responsibility for the allegation(s), no hearing will occur but outcomes will be reported.

Appeals Process

Appeals may be submitted for review by the National Standards Committee on the following terms:

- **Proper procedure** not followed by the Standards Committee
- New evidence is available that wasn't during the time of initial hearing
- Demonstrable bias on the part of the Hearing Panel existed during the hearing
- Misalignment between the violation and the outcome(s) and/or behavior-correcting measures

Appeals must be submitted to the Executive Director within 30 days of receiving a hearing outcome notification.

National Standards Committee may return one of the following decisions:

- Uphold original outcome(s) and/or behavior-correcting measure(s)
- Modify the behavior-correcting measure(s)
- Vacate the results and render a new outcome and/or behavior-correcting measures.
